
Sub: Facility of accommodation to affiliated Railway Trade Unions of recognized Federations.


Subsequent to Secret Ballot Elections (SBE) – 2024, AIRF and NFIR have secured recognized Federation status. Their affiliated Trade Unions as well as other recognized Trade Unions, on Zonal Railways and PUs (CLW & RCF), have been granted certain facilities including office accommodation at Zonal and Divisional level.

2. The two recognized Federations i.e. AIRF & NFIR have, however, represented that they may be provided the facility of office accommodation on all the Zones and Divisions for carrying out Federation/Unions related work.

3. The matter has been considered in Board's office and it has been decided that suitable office accommodation may be provided to the recognized Trade Unions and affiliates of the recognized Federations i.e. AIRF and NFIR on all zones/divisions –wherever not already provided to them, to enable them to carry out Unions/Federation work limited to staff matters, on applicable rent/ charges basis.

4. The policy will be reviewed after one year.


It is brought to your notice that in the recently conducted Secret Ballot Elections SBE-III / 2024, the Southern Railway Employees' Sangh (affiliate of NFIR) has secured 18.25% of Total Valid Votes Polled and subsequently the administration issued orders (vide reference No.1 above) for provision of Notice Board and Gate Meetings in terms of Section 5.10 of Final Modalities issued by Secret Ballot Election Committee constituted by Railway Ministry.

Now as per the Railway Board order dated 08.07.2025 vide reference No.2, SRES the affiliate of NFIR is eligible for the facility of office accommodation at Zonal and Divisional level for carrying out Federation / Unions related work.

Hence, the Sangh requests PCPO/S.Rly., to issue suitable PBC Circular to the Officers concerned in Headquarters, Divisions and Workshops to arrange for providing facility of office accommodation to enable us to carryout Unions / Federations work.

In this connection, apart from issuing orders, PCPO is also requested to earmark accommodation for NFIR/SRES at HQRS Office.
