Sub: Request of Hospital Attendants/Assistants to appear in the selection for promotion to the post of Office Clerk against promotion (33-1/3%) and LDCE (16-2/3%) Quota Examinations - grievance of staff of Southern Railway - reg.

It has been reported to the Federation by our affiliated Union (SRES) that the Railway employees functioning as House Keeping Assistant (Safaiwala) in the Railway Hospital, Perambur, Chennai, re-designated as Hospital Attendant, are being denied to appear in the selection for promotion to the post of Office Clerk against 33 1/3% and 16 2/3% quota vacancies arising in the Medical Department. Reports received further reveal that the Southern Railway Administration has permitted only House Keeping Assistants to appear in the above-mentioned selections.

In this connection, Federation (NFIR) desires to bring to the notice of Railway Board that the employees belonging to the category Safaiwala in the Railway Hospital, have been put to work as House Keeping Assistant since October 2016 and they worked upto 2019, thereafter they have been redesignated as Hospital Attendant since the year 2019 after passing the examination conducted by the Administration. Here it is relevant to mention that their Pay Level-1 (GP 1800) remains the same as of Safaiwala.

Railway Board may appreciate that the extant instructions provide opportunities to Hospital Safaiwala for promotion as Office Clerk against promotion and LDCE quota vacancies and denying the opportunity to those Safaiwala working as Hospital Attendant is grossly unjustified. Federation also desires to convey that good number of those working as Safaiwala/House Keeping Assistant/Hospital Attendant possess educational qualification of 12th Class Pass, Degree and other higher courses and they are hopeful of clearing the examinations.

NFIR, therefore, requests the Railway Board to kindly consider the genuine demand of Safaiwala/House Keeping Assistants/Hospital Attendants and issue instructions to the General Manager, Southern Railway to allow them to appear in the selections for promotion to the post of Office Clerk against 33 1/3% and 16 2/3% quota vacancies in terms of extant instructions.

Subject: Eligibility for selection to the post of Office Clerk against 33%/ promotional and 16%/ LDCE quota vacancies.

Representations from Railways and the Staff Side are being received from time to time regarding issuing guidelines on the eligibility of House Keeping Assistants/Hospital Attendants of Medical Department to appear in the selection examination for Clerk-cum-Typist posts under the 33%/ promotional and 16%/ LDCE quotas.

2. In this regard, attention is drawn to Para-174 & 189 of IREM, Vol. I wherein, Zonal Railways are allowed to decide feeder categories to be eligible for promotions there under subject to certain terms and conditions. The matter has therefore been examined, and it is advised that Railways may take action at their own level accordingly, depending on local conditions prevailing and decide eligibility of Hospital Attendants to be covered for promotions under Para-174 & 189 (supra) of IREM Vol.I in consultation with the recognised unions. However, in the case of eligibility of House Keeping Assistants, relevant instructions have already been issued vide RBE 77/2016 to be read with RBE 163/2018.
