

OFFICE MEMORANDUM

Subject: Disbursement of salary/wages/pension to the Central Government Employees in the State of Bengal for the month of September, 2025 on account of Durga Puja/ Dussehra festivals in Bengal-reg.

In view of the Durga Puja/ Dussehra festivals, the Government has decided that the salary of all Central Government employees in the State of Bengal for the month of September 2025 may be drawn and disbursed by the Central Government offices (including Defence, Posts & Telecommunications) on 26<sup>th</sup> September 2025 (Friday).

- The wages for September, 2025 of the industrial employees of Central Government serving in the State of Bengal may also be disbursed in advance on 26<sup>th</sup> September 2025.
- The pension for September, 2025 of all Central Government Pensioners in the State of Bengal may also be disbursed by Bank/PAOs on 26<sup>th</sup> September 2025.
- The salary/wages/pension so disbursed is to be treated as advance payments and will be subject to adjustment after the full month's salary/wages/pension of each employee/pensioner is determined. The adjustment, if any, will be made without exception from the salary/wages/ pension of the month of September 2025.
- The concerned Ministries/Departments are requested to bring these instructions to the notice of their offices located in the State of Bengal for necessary action immediately.
- Reserve Bank of India is requested to bring these instructions to the notice of all paying branches of all Banks located in the State of Bengal for necessary action immediately.

Sub: Disbursement of salary/wages/pension to the Central Government Employees/ Pensioners for the month of September, 2025 on account of Durga Puja/Dussehra Festivals in India-reg.

Ref: Ministry of Finance (Department of Expenditure)'s O.M. No. 03002(2)/1/2020/TA-II/(e-3001)/337 dated 12/15-09-2025.

The Government of India vide Ministry of Finance (Department of Expenditure)'s O.M. No. 03002(2)/1/2020/TA-II/(e-3001)/337 dated 12/15-09-2025 have issued instructions to disburse the salary/wages/pension to the Central Government Employees/Pensioners for the month of September, 2025 on account of Durga Puja/Dussehra Festival on 26<sup>th</sup> September, 2025 (Friday). A copy of the said O.M. is enclosed

Federation takes note that the orders issued by the Ministry of Finance (Department of Expenditure) are limited and confined only to the Central Government/Pensioners in the State of Bengal. Federation feels that the said order is arbitrary & discriminatory in as much as the Durga Puja/Dussehra Festivals are celebrated throughout the country. The Central Government Employees/Pensioners including Railway employees/Pensioners throughout the Indian Railways are therefore eligible to receive payment of salary/wages/pension for September, 2025 in advance and the same should also be disbursed to them on 26<sup>th</sup> September, 2025 (Friday) similar to the O.M. dated 12/15-09-2025 relating to the State of Bengal without any discrimination.

NFIR, therefore, requests the Railway Board (DG/HR & Member/Finance) to kindly intervene and see that orders are issued by the Railway Ministry to disburse salary/wages/pension to the Railway employees/pensioners on Indian Railways on 26<sup>th</sup> September, 2025 (Friday) to maintain parity. A copy of the instructions issued may kindly be endorsed to the Federation.
