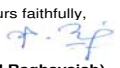

Modiji, Sub : General Budget 2019 – NFIR's proposal for consideration-reg. ***** In the wake of Budget - 2019 proposed to be introduced in the Parliament in February, 2019, the National Federation of Indian Railwaymen (NFIR) requests the Hon'ble Prime Minister to kindly consider the proposals listed below for the purpose of inclusion in the ensuing Budget:- 1. The Income Tax Exemption limit may be revised to not less than 5 lakhs per annum. 2. The Income Tax Exemption limit for Sr. Citizens may be revised to Rs.10 lakhs p.a. 3. The Single Female Government Employees be granted "Old Age Parents Care Leave" on the pattern of Child Care Leave. 4. The Female Government Employees be allowed 5 days extra Casual Leave to help them in maintaining their health (specially female below the age of 50 years) keeping in view the menopause stage leading to complications such as hormonal changes similar to physically challenged employees. 5. Flexi timings be provided for women and physically challenged employees working in the Central Government Departments in the field as well in Offices. 6. Child Care Leave for women employees be enhanced to 1400 days during the service period. 7. Provision for Child Care Leave for widower Central Government Employees be made with facility of Child Care Leave upto 750 days in the entire service. Contd. Accumulation of earned leave/leave on average pay (LAP) beyond 300 days may be allowed and accounted for in the case of Central Government Employees. The Punjab & Haryana High Court (at Chandigarh) had delivered Judgment directing the respondents to credit earned leave even beyond 300 days to the account of employees. 9. Family Planning Allowance already granted to the Central Government employees till 30th June 2016 should be continued as the Allowance was granted pursuant to the statutory provision. 10. Defence Forces Personnel re-employed in Government Departments / Organizations be provided relief duly granting them pay re-fixation on the basis of last pay drawn at the time of retirement from Defence Forces. 11. Provision be made for reimbursement of expenses incurred for dental treatment in the case of Central Government employees as well retired employees and their dependents as part of Health Care facilities. 12. Fixed Medical Allowance (FMA) to the retired employees and pensioners be revised from Rs.1000 to 3000 p.m. 13. Provision of Shelter Homes for the retired Central Government Employees at different locations. 14. Reimbursement of college/hostel fees in the case of wards of retired Government Employees. 15. Provision of accommodation for the office recreation purpose to the Pensioners Organisations.
