SAFETY CATEGORIES

STEPS TAKEN BY NFIR :

- NFIR had already placed a PNM Agenda No. 14/2018.
- Railway Board constituted a Committee to examine all Safety Categories vide Letter dated 11.02.2019 & 20.02.2019.
- This was already published by SRES vide Circular No. 933, 942 & 942-A which is uploaded in SRES Website.
- GS/NFIR submitted the Department-wise proposals to the Committee, to consider R&H Allowance to the following categories also.
