HOW SRES–NFIR GOT REVISED DUTY ROSTER OF ALLEPPEY SECTION FROM 12 HRS TO 8 HRS

SRES-NFIR HAD FOUGHT IN NEGOTIATION, THROUGH STREET PROTESTS & THROUGH COURT

- 1) Job Analysis have not done for 35 gates in Alleppey section despite representations.
- 2) SRES NFIR discussed in the Rly. Board PNM Sub. No. 31/2015 and again discussed in Sub. No. 34/2016.
- 3) Job Analysis on 14 + 21 Gates were conducted in the year 2016 and Memorandum were issued from 12 hrs to 8 hrs duty on 15.06.2016 & 23.02.2017.
- 4) Rly Board addressed letter to all GMs and copy to GS/NFIR on 30.09.2016.
- 5) We demanded Overtime to be paid as per HOER, Rly. Board Order dated 05.12.1974.
- 6) It was not implemented by TVC Division despite our SRES representations.
- 7) GS/SRES & JGS/NFIR wrote letter to DRM on 01.07.2017.
- 8) GS/NFIR wrote letter to GM on 13.09.2017.
- 9) Again it was reminded to DRM by GS/SRES & JGS/NFIR on 21.11.2017.
- 10) Shri.Johnson Joseph, Chairman/SRES Alleppey Branch approached Court and filed OA No.919/2017/100 against nonpayment of overtime allowance from 14.01.2016 onwards.
- 11) A Memorandum was submitted to CRB on 20.01.2018 @ Chennai.

After 2 ½ years struggle finally in the month of June 2018, many employees have got arrears in Lakhs of rupees, some of them have got Rs.2,75,000/-.



Sub : Representation of GS / NFIR / NDLS – Revision of classification of Gate Keepers from "E1" to "Continuous" under HOER on Trivandrum Division – Implementation of decisions – reg.

Ref : GS / NFIR / NDLS Lr. No.III / SRES / Part XIV dated 13/09/2017 addressed to GM/S.Rly.

In reference to the above, it is advised that sanction was accorded to reclassify, 35 Engineering LCs under SSE/P.Way/Alleppey located between Kumbalam (KUMM) – Tiravur (TUVR), Sherthala (SRTL) – Maraikulam (MAKM) and Mararikulam (MAKM) – Alleppey (ALLP) from "Essentially Intermittent" to "Continuous" under HOER. However in view of the acute shortage of staff, SSE/P.Way/Alleppey has not implemented the reclassification order and the Gate Keepers are eligible for overtime allowance in excess of 8 hours per day. SSE/P.Way/Alleppey has been instructed to claim Overtime Allowance to the eligible staff at the earliest.
