## UPGRADATION OF THE GRADE PAY OF TECHNICAL SUPERVISORS

### RAILWAY BOARD PNM Sub. No. 3/2018 & 10/2018

Railway Board replied to GS/NFIR vide Lr. No. PC-VII/2015/R-U/9 dated 17.04.2018 as under

Now, Board have agreed to consider our proposal of GP 4800 & 5400 to the Technical Supervisors. The present 67% of SSEs will be redistributed to 12% in GP 5400, 15% in GP 4800, 40% in GP 4600.

Sub: Representation of NFIR regarding upgradation of pay structure of JEs/SSEs.

Please refer to your letter No. IV/NFIR/7<sup>th</sup> CPC(Imp)/2016/R.B./Part II dated 19.02.2018 requesting Railway Board to examine the Pay structure of JEs/SSEs *denovo* taking into account the cadre structure from 3<sup>rd</sup> CPC and onwards for the purpose of granting revised cadre structure as below :

S. No.	Designation	6 <sup>th</sup> CPC Grade Pay/Level in 7 <sup>th</sup> CPC	Percentage
1	Junior Engineer	PB-2, GP-4200/Level-6	33
2	Senior Engineer	PB-2, GP-4600/Level-7	40
3	Section Engineer	PB-2, GP-4800/Level-8	15
4	Sr. Section Engineer	PB-2, GP-5400/Level-9	12

2. With respect to above, it is stated that the present proposal regarding upgradation of 75% Senior Supervisors in Group 'C' of all Departments (other than Accounts Department) from Level-7 (erstwhile GP 4600) to Level-8 (erstwhile GP 4800) alongwith a proposal to bring parity in the pay scales of Group 'B' Officers amongst Accounts/Non-Accounts Departments is a outcome of comprehensive analysis of pay structures of Group 'B' Officers and Senior Supervisors prevailing from 3<sup>rd</sup> CPC and while sending the same to Ministry of Finance vide letter dated 08.02.2017 upsetting of established relativities since acceptance of 6<sup>th</sup> CPC recommendations have been highlighted. Further, this proposal has been followed up by a D.O. letter dated 20.04.2017 from Hon'ble MR to Hon'ble FM seeking early approval. A meeting has also been held with officials of Ministry of Finance on 21.02.2018. This is also linked with the proposal that is to be considered by the Committee Constituted by DoP&T consisting of representatives of Ministry of Finance, DoP&T and Ministry of Railways to examine the recommendations of 7<sup>th</sup> CPC to upgrade the Pay Scales of certain categories including Ministry of Railways.

3. Since, proposal above is already under consideration presently, it would be appropriate to await a decision on the same rather than taking up any fresh proposal at this stage.
