Based on the notification cited under above reference No.1, examination was conducted for selection of Goods Guard in pay matrix Level 5 (PN Rs.5200 – 20200 + GP 2800) of VII CPC. The Examinations were held on 07.08.2019 and the supplementary examination was also held on 22.09.2019.


Majority of Volunteers belonging to Mechanical, Engineering, Electrical Department, etc felt that questions were on LDCE pattern and not on GDCE pattern. It seems that the staff belonging to Operating Department were at an advantageous position as nearly 40% of the questions were from GRS.

Since staff belonging to other departments are not trained in GRS, they are unable to answer the questions pertaining to GRS.

GDCE examinations are being conducted for the benefit of serving Railway employees irrespective of the departments in which they work and hence the questions also should be on RRB pattern meant for direct recruits.

We request our General Manager to kindly intervene in this matter and take appropriate action to render justice to all staff.
