Outcome of DC-JCM held on 5th – 6th, October 2021

Shri. P.S.Suriyaprakasam–JGS/NFIR discussed the
following issues in the DC-JCM.**

- 1) **NFIR/SRES have pointed out that Track Maintainers are greatly frustrated for career growth** - CRB had agreed to process 10% LDCE quota for all categories and Special Consideration for Track Maintainers.
- 2) **DC/JCM Sub. No. 12/2021 : Denial of opportunity to Artisan Helpers for filling the vacancies of JE (P. Way) against LDCE quota of 20%** - P.Way Artizan Helpers are also allowed to compete for 20% JE / LDCE Quota. Rly Board agreed and orders will be issued.
- 3) **DC/JCM Sub. No. 10/2021 : Grant of MACP GP 4800, 5400 to SSE/JE(Drawing/Design)** – under examination, seperate meeting will be held.
- 4) **DC/JCM Sub. No. 17/2021 : Computation of Tax for Running Staff and Payment of Arrears of KMA** – Our demand has been considered by Rly Board and Yearwise calculation will be made.
- 5) **Forwarding of Request Transfer Applications to other divisions / Railways** – We have highlighted the above problem and Rly Board agreed to examine.
- 6) **DC/JCM Sub. No. 13/2021 : MACP to IT Cadre** – under examination.

- 7) **DC/JCM Sub. No. 9/2021 : Re-deployment of Running Staff/Motorman involved in SPAD cases** – Elaborate discussion took place in the DC/JCM. NFIR put forth all the factors to take into account. AM/PED Safety has agreed to consider sympathetically.
- 8) **DC/JCM Sub. No. 7/2021 : Payment of arrears of KMA and ALK to Loco & Traffic Running Staff, Computation of Income Tax thereon** – under consideration.
- 9) **DC/JCM Sub. No. 3/2021 : Age relaxation for 10% Lateral induction of Track Maintainers** – Rly Board agreed to relax the age from 38 yrs to 33 yrs.
- 10) **DC/JCM Sub. No. 2/2021 : Procedure for Promotion of Technician Category** – Done away with viva-voce examination to Technician Category is under examination
- 11) **Productivity Linked Bonus for the year 2020-21** – Number of days bonus will be announced.
- 12) **NDA for all categories** – All will get NDA without ceiling.
- 13) **S.No.45 of Action Taken Statement : Improved Pay for Paramedical Staff** – agreed to process
- 14) **DC/JCM Sub. No. 11/2021 : Grant of Family Pension and Gratuity to the eligible members of the family of an employees covered under NPS reported missing** – Board agreed to examine.
- 15) **DC/JCM Sub. No.29/2021 (A&B) : Coverage under Railway Service (Pension) Rules, 1993 in place of NPS - Cases of CG Appointment & Coverage of Substitutes appointed prior to 01.01.2004 under Railway Service (Pension) Rules, 1993 in place of NPS.** – Board agreed to consider NFIR's request of switching over from NPS to OPS.
