## INTER RLY. TRANSFER - SERVICE CONDITION

SRES/NFIR discussed in the Rly. Board PNM under Sub. No.36/2015 for considering Inter Rly. Request Transfer applications, a comprehensive transfer policy was evolved & orders issued by Board on 31.08.2015, also circulated by Personnel Branch vide PBC 14/2016.

Now, Board issued order dated 10.03.2022 to increase the service condition of 5 yrs to 10 yrs. After the speedy action taken by GS/NFIR vide letter dated 21.03.2022 (uploaded in SRES website), Board issued a Corrigendum that the powers delegated to GM to relax the service condition of 5 yrs plus.

The matter has accordingly been considered and para 3 of the said letter is modified to read as under:-		
<i>"The matter has accordingly, been considered by the Board, and in partial modification of Board's letter dated 03.08.2015 cited above, it has been decided that General Managers, in consultation with the recognized Trade Unions, may increase the minimum service period for Inter-Railway transfer from 5 years to 10 years for specific categories in non-gazetted cadre, keeping in view the need for manning important posts for smooth train operations."</i>
