MAS Division had published Question Bank for PRQ for Goods Guard.

You are also aware that vide under above reference No.2, the questions are 100% objective type questions. But till date no question bank was published to all categories. **NFIR had already secured order through Railway Board PNM under sub. No. 2/2017 & 2/2018.**

South Central Railway had supplied question bank even for Compassionate Ground selection. Now, MDU Division had issued final list of eligible incumbents for 25% PRQ selection for the post of Station Master on 13.07.2021. But so far no question bank was supplied to their workers. Many employees are eagerly waiting for supply question bank.

Therefore, NFIR/SRES requests you to kindly take expedite action for supplying of question bank at the earliest date adhering the above Railway Board orders.
