Sub : Granting of additional incentive increments to 57 sportspersons of Southern Railway for their achievements before 2010 - reg.

Kindly refer our representation vide under above reference No.4. 57 Sports Personnels are eligible to get increments as per Railway Board letter under reference No.1 and PCPO letter dated 25.09.2017 vide under above reference No.2. Though the Sports Personnel had brought laurels for India and Indian Railways, the increments were granted for the recognition of their sports achievements by Board on 31.07.2017, however the benefits were not granted in Southern Railway even after repeated representations. After efforts made by NFIR/SRES through NFIR PNM Sub. No.57/2018 in the Railway Board, finally Board issued order on 19.12.2020 vide under above reference No.7 (copy enclosed for ready reference) that powers delegated to GM for claiming the increment without any further delay.


We came to know that the increment had been sanctioned but it is delayed in HQRS for want of clarification. Now, we came to know that Accounts was seeking clarification vide under above reference No.8. Clear instructions were given by Board to pay the additional incentive increments to Sports persons. Due to inordinate delay, making one another reference, etc., the Sports Personnels who brought laurels to Country / Railways were greatly disappointed and frustrated. It is a great insult to the Sports Personnels. Some influenced / vested interest persons deliberately delaying the claims.

We therefore request our Hon'ble GM cum Patron/SRSA to kindly interfere and take necessary expedite action as the above issue is already delayed for more than 10 - 25 years.

PFA vide their letter dated 07.04.2022 have made observations (copy enclosed) for the grant of increments prior to 2010 and also the mode of submitting the proposal by the Divisions/Units as per their proforma.

The points stated by PFA in their letter may be adhered to and all the requests made to Railway Board earlier for the grant of such increments should be forwarded to this Office for seeking Accounts concurrence. In addition those sportspersons who have not applied earlier can also apply now for the increments prior to 2010, if eligible. The Divisional Accounts should certify the proforma submitted by the sportspersons of the Divisions / Units before being forwarded to this Office.

The proforma attached may be filled in all aspects alongwith documentary proof of the achievements and also the policy in vogue for the grant of such increments. They are to be forwarded by the Divisions /Units within 15 days for further action.
