Railway Board vide their letter under reference has advised RDSO to explore the feasibility of separate seat in Electric Locomotive cab for foot plating officials addressing the pros and cons thereof.

In this regard, ELS/BZA provided seats for inspecting official with foot rest on trial basis on back side of LP seat (Cab-1) and on backside of ALP seat (Cab-2) in two WAP-7 (Loco no. 37344 & 30602) Locomotive. Photograph attached as annexure-1. ELS/BRC also provided seat for inspecting officials in two WAP-7 (Loco no. 30507 & 37383) Locomotive. Photograph attached as annexure-2.

However, possibility of using a small foldable seat, which can be kept at suitable location in machine room (in folded condition) and can be used as and when required, can also be explored instead of creating permanent arrangement.
