You are aware that the entire Chennai and neighbouring districts were inundated due to Michaung Cyclone, never in the past 47 years history the entire train services was stopped. There were no city bus services due to water logging in the roads. The entire city was paralysed. However, very few skeleton staff came to duty for emergency work. Many employees also tried to come for duty on their own vehicle but due to water logging they are unable to come. The neighbouring districts Tiruvallur & Chengalpattu district (Kancheepuram) also marooned. The State Government had declared holiday on 04.12.23 & 05.12.23.

We therefore request you to kindly grant SCL on 4.12.2023 & 05.12.2023 to the staff who could not come for duty consequent upon cancellation of suburban trains and road services.
