Sub: Retired Employees Liberalized Health Scheme (RELHS-97).

Ref.:Board's letters No. 2003/H/28/1/RELHS dated 28.01.05, 21.10.05, 30.12.05, 10.05.06, 10.01.07 & 16.03.09.

Arising out of demands raised by Federations & various Pensioner Associations, the subject matter of facilitating Railway Medical Services to all Retired Railway personnel through RELHS-97, had been under consideration of Board for some time. After careful & detailed examination of the matter the following has been decided by Ministry of Railways –

- (a) For Pre-March 2009 retirees The RELHS-97 will remain open-ended with a lock-in-period of six months for referral outside the Railway Hospital with the rider that this lock-in-period can be relaxed only in an emergency provided the patient is either admitted or visits the Railway Hospital and the facilities for the treatment are not available in Railway Hospital. Such referrals are to be processed only on recommendation of a specially constituted Medical Board.
- (b) For March 2009 and onwards retirees The RELHS-97 will remain open for a period of another one year from the date of issue of the letter for all those retired railway personnel who have not joined the scheme for one reason or the other. The lock-in-period of six months as applicable for pre-March, 2009 retirees shall be applicable for these retirees also. Henceforth joining RELHS-97 has been made mandatory for all retiring Railway personnel without any exit clause whatsoever.

All other terms and conditions of RELHS-97 mentioned in Board's letter dated 16.03.2009 under reference will remain unaltered.

This has the approval of the President and issues with the concurrence of Finance Directorate of Ministry of Railways. Wide publicity should be given to the above provisions.

FLASH NEWS TO PENSIONERS

As a result of NFIR's persistent demand for making RELHS-97 as open scheme for the Retired Railway Employees, the Railway Board convened a Special meeting with DG/RHS to discuss our demand for converting RELHS-97 as open scheme. In the special meeting between NFIR and DG/RHS, various aspects were discussed, consequently it was agreed as follows:

Pre-2009 retirees, who have not opted for RELHS-97 will have the option to opt for the scheme as the said

scheme will be kept open for them.

Those who have given option not to become RELHS-97 beneficiaries (post-2009 retirees) will be made elligible to opt for RELHS-97 and the time limit for opting to switch over to RELHS-97 would be one

However, Para No. 3. & 6 of Board's letter no. 2003/H/28/1/RELHS dated 16-03-2009 will continue to be in force so far as remittance of the amount equivalent to the double of revised pension within a lock in period of Six months.

On 04-04- 2012, AIRRF Central Team, discussed various other issues concerning pensioners in the

Railway Board.

All Pensioners are therefore requested to note this big achievement and give vide publicity amongst all pensioners, who have not yet enrolled as members under RELHS-97 scheme. Incidentally it is to be mentioned that the "Extension of scope of Family pension to un-married daughters of Central Government Servants / Pension to Un-married daughters" vide Ministry of Pensions / Pensioners Welfare Letter no - 01/19/03 -P&PW(E) dated 16-09-2007 is the outcome of discussions between NFIR and J.C.M. The entire credit goes to the General Secretary NFIR Sri M. Raghaviah, as during his visit to Kharagpur on 18-11-2006 for attending AIRRFS's - AGM, the issue was placed before him, by the undersigned; Accordingly the issue was taken up in National Council and after threadbare discussions, Pension Ministry agreed to sanction. Family pension to un-married daughters at par with widow / divorced daughters. We convey our thanks.

Today, as a result of these orders, hundreds of un-fortunate un-married daughters of Railway Employees are getting Family Pension (Rs.3500/- + 58% DR) which I feel is a great achievement for NFIR &

AIRRF. We have also recommended several cases, after scrutiny of all particulars of each case.
