Shri. Bhabani Sankar Patra, ESM-II, S&T Dept/Pune/CR has joined Southern Railway as Health Inspector / MAS vide under reference No.1 quoted above. His case history is as under:

Though the employee has put in more than 8 years service as a ESM Gr.II / Gr.I and earned 8 years increment, at the time of leaving from the post of ESM he was drawing Rs,10610/- but after joining in S.Rly in higher grade he was fixed only Rs.9300 + 4200 for which the employee is incurring lose Rs.1310/- in the pay band pay + DA, HRA, TPTA etc. As per Railway Board extant order the monitory benefit to be protected when he joined in the new unit, since the employee after obtaining the NOC only he appeared in the RRB. He was selected through RRB/Chennai and joined as Health Inspector on 28.01.2016. After joining in Southern Railway his fixation was not done correctly. We have already represented to ADRM II / MAS vide under above reference No.3 dated 08.09.2017, but no tangible action was taken.

In this connection DOPT has also given order for Pay protection of past service vide under above reference No.2. We therefore request you to kindly arrange for correct fixation of pay without losing any monitory benefits.
