You are aware that NFIR had moved a serious anomaly agenda about fixation of pay of promotees who were promoted between 1.1.2006 and 31.12.2015, their minimum pay band pay should have been fixed at par with Direct recruits. This has been accepted and recommended by Ministry of Finance vide Lr. No. OM No.8-23/2017 E.IIIA dated 28.09.2018 and Railway Board had issued orders vide under above reference to refix the promotees pay at par with direct recruits. But even after 6 months have passed no tangible action was taken.

1. The following JEs of TNPM/DSL Shed were promoted as SSEs vide Office Lr. No.M/P(1M)/563/VI/DSL/Sup. dated 21.11.2014, they were fixed pay lower than the directly recruited SSEs. We therefore request you to kindly refix their pay Rs.17140/- on par with direct recruits as per Rly Board order under above reference.
