**Sub : a) Inter Railway Request transfer applications – considering off.
b) Inter Division Request transfer application considering off.**

The following are brought to your kind notice for humanitarian consideration and necessary action please.

1) **Inter Railway / Inter Divisional Request transfer application processing.**

To mitigate the problems facing by employees for non forwarding of request transfer applications., NFIR had placed Railway Board PNM Agenda No. 30/2003, 45/2005, 36/2015 & 18/2016 and order secured from Railway Board for evolving comprehensive transfer policy vide Rly Bd. Lr. dated 31.08.2015 and it was also circulated by CPO vide PBC No. 14/2016 & 57/2016.

In regards to Inter Railway Transfer who have submitted applications and registered, the number should be advised to Railway Board vide Lr. dated 18.01.2019. A Action plan to be drawn.

2) **Non forwarding of request applications of option for new projects.**

It is pertinent to mention that eventhough NFIR has insisted vide PNM Sub. No. 50/2016 to allow option for staff to work in Workshop Project organization / Patna, Wagon Repair Workshop / Badnera / Central Railway, Coach Midlife Rehabilitation Workshop/Kurnool, S.C.Railway and Wagon Repair Workshop, Vadlapudi, E.Co.Railway, HHP Loco Shed/Barauni, etc., dated 5.1.17, but many applications were not forwarded.

3) **139 Post of Multi Tasking Staff vacant at Railway Board/NDLS.**

Railway Board issued circular Lr. 2018/ERB-5/5(4)/01 dated 08.08.2018. Again on GS/NFIR requests Board extended the date upto 5.10.2018 vide Rly Bd. Lr. 2018/ERB-5/5(4)/01 dated 31.08.2018. However, many applications were not forwarded.

4) **RRB / RRC recruitment process.**

Now, the RRB/RRC recruitment process was almost over. Number of candidates about to be allotted to the divisions.

In selective manner very few Inter Railway / Inter Divisional request transfer applications were considered by administration without following the priority norms which gave room for lot of criticism and unlawful activities. We request to first register all the application and in future the priority list should be uploaded in the website.

We therefore request Hon'ble General Manager to kindly consider all inter divisional / inter railway request transfer at the earliest please.
