In connection with the above selection the following are brought to your kind notice and necessary action please.

- 1) S.No. 13 of Sri. B.Rajesh Kumar, AC Helper, SSE/AC/TL/MS has been selected in the 25% LDCE written examination and result was published vide reference No.1.
- 2) The final panel list was published on 22.02.2019 vide under reference No.2, his name was not figured in the final list.
- 3) The written examination mark alone published on 18.06.2019 vide under reference No.3 after issuance of final panel list on 22.02.2019.
- 4) His professional ability and records of service marks were not appraised. Other candidates marks also were not openly published.
- 5) In terms of Railway Board order the professional ability and records of service marks were not published. The candidates are kept in dark. Further the written examination marks was published after final panel which is also against the Railway Board Guidelines.

Though Sri.B.Rajesh Kumar secured 61.5 marks was not selected, whereas other candidates who secured less than Sri.B.Rajesh Kumar were selected. His representation dated 20.06.2019 was not disposed till date. Reason for not publishing professional ability and records of service marks is not known till now. The employee has put in unblemished service, he has been working with entire satisfaction of his superior without any adverse remarks and also he is very amenable.

We therefore request you to kindly take necessary action and adhere the Railway Board order & selection guidelines Para No. 11.4.2.3 for the above selections.
