Sub: Allowing Technicians category staff in Grade Pay Rs. 1800/Pay Level I working in EMU, DEMU and MEMU Sheds to volunteer for selection against 50% quota of ALPs- Extension of opportunity to those in other Technical Departments to make good the short-fall if any, against 50% quota - reg.

Responding to Railway Board's instructions issued vide RBE No. 69/2018 dated 14<sup>th</sup> May 2018, on NFIRs PNM Item No. 8/2018, Federation vide its letter dated 30/07/2018 requested the Railway Board to allow staff working in GP 1800/Level-1 of 7<sup>th</sup> CPC, including Track Maintainers, who possess the requisite qualification, to appear in the selection of ALP against 50% quota to facilitate the Divisions to utilize the allotted quota fully. Federation is yet to receive Board's response.

In this connection, the employees possessing the educational qualification to the posts of ALP and have been recruited in GP 1800/Level-1 or GP 1900/Level-2 through RRC/RRBs have also demanded that they be allowed to appear in the selection for meeting the shortfall of 50% quota. Federation feels that the demand of such staff is genuine and deserves to be conceded.

NFIR, therefore, requests the Railway Board to kindly consider Federation's proposals dated 30/07/2019 and as mentioned above and issue instructions for permitting the staff of technical departments in order to facilitate for making full use of the 50% quota vacancies from serving staff. A copy of the instructions issued may be endorsed to the Federation.
