

Payment of Allowance to the Running Staff in lieu of Running Room facilities-Upward revision-requested.

The reply sent by the Railway Board to GS/NFIR vide letter dated 18/10/2019 reveals that genuineness of the issue raised has not at all been taken into consideration therefore, the Federation is unable to agree with Board's view. The merits listed below deserve consideration.

- While the subject was tabled vide PNM Agenda Item No. 39/2016 and discussed in the special meeting held with the Railway Board (EDPC-I) on 04/06/2019, Federation vide its letter dated 25/07/2019 has again sent an elaborate letter citing relevant rules contained in IREM Vol. I (Para 908) wherein provision exists relating to payment of Allowance in lieu of Running Room facilities to the Running Staff.
- Railway Board may please appreciate that these situations arise mainly at outstations
  where Running Rooms are not provided. Experience also reveals that this Allowance is
  admissible to the Running Staff at road side stations irrespective of the fact whether
  trains get terminated or otherwise.
- Board is also aware that the Running Room facilities are not available at outstations and
  as a compensation to meet with the out of pocket expenses incurred by the Running
  Staff, Compensatory Allowance i.e. Allowance in lieu of Running Room facilities is
  allowed. The revised rates of Rs. 112, 81 & 70 respectively are totally inadequate and
  practically do not meet with the expenses actually incurred by the Running Staff.

- Considering the inadequacy of the amount mentioned in Para 4.1 of RBE No. 85/2019 dated 28/05/2019, the subject was discussed in the special meeting held on 04/06/2019 and full justification was also furnished vide Federation's letter dated 25/07/2019.
- Railway Board may kindly take note that the revised rates, mentioned above are in no
  way commensurate with the market rates as the same are grossly insufficient to meet
  with the lodging/boarding facility being availed by the Running Staff at outstations.

NFIR, therefore, requests the Railway Board to kindly have re-look and revise the rates to compensate realistically. A copy of modified instructions on the subject may be endorsed to the Federation.
