**Sub : Selection for the post of Ticket Examiner in GP 2000 (Level 3) against
16 2/3 % LDCE quota).**

It is represented that to fill up LDCE 20 vacancies against 16 2/3% volunteers were called from PB branch of Salem division vide under ref. No. 1 dated 31.01.2019 and syllabus for written examination for the post of Ticket Examiner also published on the same letter. The written examination was held on 11.3.2019 and result was published on 26.3.2019 vide reference No.2. 32 employees have qualified in the written examination. The final panel was issued on 13.09.19 vide under reference No.3, wherein 19 employees have been selected. The result of Training Course was published on 17.12.2019.

In this connection, NFIR/SRES would like to bring to your kind notice that when employees are called for the above selections and the syllabus was issued for Ticket Examiners only. All letters envisages for filling up of the post of TE only. But, we came to know that the selected candidates are likely to be posted as Commercial cum Ticket Clerks. Further the result of LDCE Station Master and Ticket Examiner were published on the same time. The seven employees names were present in both the lists ie. they got selected for both the LDC Examination. The DPO had called these employees and demanded to give unwillingness either to SM or Ticket Examiner post. The six employees gave unwillingness for SM posts and one employee for Ticket Examiner post. The reason behind to give unwillingness to SM post by six employees was because of getting TE post for them. But these employees are likely to be posted as CCTC only instead of Ticket Examiner.

As long as they were called for TE posts and employees were given willingness and appeared for the examination based on the TE syllabus, but suddenly changing the designation as CCTC at the time of posting order is not correct.

We therefore request you to kindly take necessary action for settling the above problems.
