With reference to Board's instructions contained in RBE No. 107/2019 & 108/2019 dated 03/07/2019 and Board's reply to GS/NFIR vide letters dated 16/07/2019 & 23/08/2019, Federation desires to convey following vital points for making amendment to the extant instructions:-

- The stipulation of matching saving provided in Para 2 of Board's instructions vide RBE No. 108/2019 dated 03/07/2019 needs to be deleted and the posts of CLI in GP 4600/Level-7 be allowed to be created on the basis of 6-monthly Review similar to the existing provision meant for Running Staff.
- The phrase mentioned in 1st/2nd line in Para 5 (Pay fixation) - *or as fixed by the competent authority* needs to be deleted as the same is in contravention of the earlier policy contained in Board's circular dated 25/11/1992.

NFIR, therefore, requests the Railway Board to issue amendments to the instructions dated 03/07/2019 (RBE No. 107/2019 & 108/2019) with the modifications suggested above to facilitate realistic implementation of Board's policy decision in the Zones/Divisions, duly endorsing copy to the Federation.
