In continuation with my telephonic conversation had with you on 3.3.2020, the LARSGESS appointees are still suffering without any communication from your office. The list of the candidates have already submitted.

In this connection Supreme Court order vide under above ref. no.1, Railway Board have already communicated that LARSGESS appointment have already processed prior to 27.10.2017 should be considered for the wards of the employees. Further, this was discussed in DC/JCM Meeting on 26.12.2019 & 16.01.2020 in presence of Railway Minister & Chairman/Railway Board. The DC/JCM minutes also were circulated to all and it is CRIS & CLEAR to consider the LARSGESS appointment prior to 27.10.2017. And also Railway Board recent letter dated 6.1.2020 vide under ref, no.4.

Apart from the repeated representations in various Forum and in the DC/JCM Meeting held on 16.1.2020 the Chairman / Railway Board has assured that he has taken steps and spoken to the General Manager. This was also highlighted in the video conference with GM.

We therefore request you to review the cases as some of them have completed medical prior to 27.10.2017. Many have also declined the promotion. The employees belong to poor family and put in unblemished service with entire satisfaction of their superiors.

Therefore, kindly arrange to take necessary action for the wards of the railway employee's appointment under LARSGESS.
